





Fees 2026





Dear parent(s),

We would like to inform you about the change in fees as of January 1, 2026. Due to national collective labor agreements and rising costs within the childcare sector, we will be adjusting our rates. On the other hand, the government will further increase the childcare allowance in 2026, which means that in many cases the net costs for parents will remain the same or even decrease.

#### Fee changes 2026

The fees within Devi Kids will increase by 5.7% for daycare and 5.8% for outside school care in 2026.

#### This increase is due to:

- Wage cost developments: wage increases, end-of-year bonuses, pension contributions, social security contributions, and staff turnover.
- Inflation in other costs, such as housing, food, and energy.
- Adjustment for 2025
- The new regulations regarding the reduction in the number of seats in outside school buses will result in an additional 0.1% increase in costs for after-school care.

Devi Kids will cover part of the increase itself through internal savings and more efficiency.

# Message from the PC

Within Devi Kids, we value the contribution of the parent committee. They were also involved in setting the fees for 2026. Below, they explain the fee changes.

To all parents/guardians of Devi Kids,

We, the parent committee, would like to inform you about the proposed fee adjustment for 2026 at Devi Kids. As we do every year, the parent committee reviews the basis for the fees and discusses them with Devi Kids to ensure that the increase is well-explained and reasonable.

## Summary of cost developments

The costs of childcare consist largely of personnel costs. These will increase in 2026 due to national agreements in the Childcare Collective Labor Agreement, periodic wage increases, and higher social security contributions. In addition, some other costs, such as accommodation and materials, will also rise.

It is important to emphasize that Devi Kids has accommodated part of this increase itself, limiting the final increase for us as parents/guardians.

## Fees 2026

The proposed rate increase is 5.7% for childcare and 5.8% for outside school care. This increase is moderate and lower than in previous years, which we as the parent committee consider positive. Devi Kids is demonstrating that it carefully balances quality, personnel costs, and affordability for parents. The 0.1% higher increase for after-school care is due to changes in regulations regarding the outside school bus. Here too, Devi Kids will absorb most of the increase itself.

## Role of the parent committee

The parent committee has reviewed Devi Kids' explanation and discussed it with the organization. We appreciate the transparent explanation of the fee structure and think it is positive that Devi Kids is absorbing part of the increase itself. We truly feel that quality and staff are being prioritized, which will ultimately benefit the care of the children.

We agree with the reasoning behind the rate adjustment for 2026.
